Introduction

On March 11, 2021, the American Rescue Plans (ARP) Act was signed into law. In it, the U.S. Department of Education is providing additional funding for the Elementary and Secondary School emergency Relief Fund (ESSER III Fund). This legislation will award grants to state educational agencies (SEAs) for providing local educational agencies (EAs) with emergency relief funds to address the impact that COVID-19 has had, and continues to have, on elementary and secondary schools across the nation.

Wisconsin will receive additional funding in ESSER III funds from the Act, with 90 percent being awarded to school districts with amounts determined in proportion to the amount of Title I, Part A funds they received in summer 2020 from funds under the Every Student Succeeds Act (ESSA). The remaining funds will be used for state-level activities to address issues caused by COVID-19.

As Nicolet Union High School plans for the start of the 2021-22 school year, we are committed to ensuring all students have access to a high-quality educational experience while doing our best to keep our staff, students and families physically healthy.

This web page serves as a hub for updates related to the 2021-2022 school year. Here, you will find information on the calendar and daily schedule. We encourage you to look to this web page for the most up-to-date information on the District's 2021-2022 plans.

The District will continue to monitor and follow the local, state and federal guidelines set forth by the North Shore Health Department (NSHD), Department of Health Services (DHS) and Center for Disease Control (CDC). The layers of mitigation strategies will be updated and refined based on this guidance.

Return to School

Nicolet Union High School will return to five day per week full in person in person learning for 2021-2022.

In-person model

All students will spend their time in the school building and resume a normal school day schedule. This will involve regular cleaning protocols, three lunches, masks and contact tracing. Proof of vaccination will be required when determining close contact and isolation periods.

Remote-Only Model

A remote-only learning option will be available for students who have a documented underlying health condition and cannot return to school in person. General information was collected from families who elected to stay in the remote second semester 2020-2021 in order to determine the need for a remote option for 2021-2022. Students in the remote setting will be scheduled for courses in an asynchronous digital learning environment through Edgenuity learning management system. Nicolet student support staff will provide progress monitoring and support for online learning. Students will be enrolled in courses that best match individual course selections, not all courses will be available via the online learning platform.

School Closure

In the event of a school closure due to the pandemic, the district will establish a remote learning model for all students. The district has implemented one-to-one Chromebooks and Canvas online learning platform that will be utilized for the remote learning model.

Department of Public Instruction

Will provide health recommendations in alignment with Wisconsin Department of Health Services (DHS) and Center of Disease Control. DPI will likely not be providing a new set of guidance for schools to follow for 2021-2022. DPI is currently planning for high school instruction in the fall to parallel spring semester 2021. Middle and Elementary school instruction will likely be based on the recommendations of CDC, DHS and DPI with local school boards determining school procedures.

CDC Guidance for COVID-19 Prevention in K-12 Schools

Updated July 9, 2021

Key Takeaways

- Students benefit from in-person learning, and safely returning to in-person instruction in the fall 2021 is a priority.
- Vaccination is currently the leading public health prevention strategy to end the COVID-19 pandemic. Promoting vaccination can help schools safely return to in-person learning as well as extracurricular activities and sports.
- Masks should be worn indoors by all individuals (age 2 and older) who are not fully vaccinated. Consistent and correct mask use by people who are not fully vaccinated is especially important indoors and in crowded settings, when physical distancing cannot be maintained.
- CDC recommends schools maintain at least 3 feet of physical distance between students within classrooms, combined with indoor mask wearing by people who are not fully vaccinated, to reduce transmission risk. When it is not possible to maintain a physical distance of at least 3 feet, such as when schools cannot fully reopen while maintaining these distances, it is especially important to layer multiple other prevention strategies, such as indoor masking.
- Screening, testing, ventilation, handwashing and respiratory etiquette, staying home when sick and getting tested, contact tracing in combination with quarantine and isolation, and cleaning and disinfection are also important layers of prevention to keep schools safe.
- Students, teachers, and staff should stay home when they have signs of any infectious illness and be referred to their healthcare provider for testing and care.
- Many schools serve children under the age of 12 who are not eligible for vaccination at this time. Therefore, this guidance emphasizes implementing layered prevention strategies (e.g., using multiple prevention strategies together consistently) to protect people who are not fully vaccinated, including students, teachers, staff, and other members of their households.
- COVID-19 prevention strategies remain critical to protect people, including students, teachers, and staff, who are not fully vaccinated, especially in areas of moderate-to-high community transmission levels.
- Localities should monitor community transmission, vaccination coverage, screening, testing, and occurrence of outbreaks to guide decisions on the level of layered prevention strategies (e.g., physical distancing, screening, testing).

UPDATE

Given new evidence on the B.1.617.2 (Delta) variant, CDC has updated the <u>guidance for fully vaccinated people</u>. CDC recommends universal indoor masking for all teachers, staff, students, and visitors to K-12 schools, regardless of vaccination status. Children should return to full-time in-person learning in the fall with layered prevention strategies in place.

HEALTH & SAFETY MEASURES

In preparation for the reopening of school the following safety practices and procedures developed in collaboration with the North Shore Health Department will be implemented for students, staff and community members:

Hand Sanitizer

Hand sanitizer stations have been installed in all classrooms and office spaces. Hand sanitizer stations will be refilled on a regular basis.

Nurses Office

An isolation room will be created for students or staff who present symptoms of COVID-19. Student medication will be distributed from a separate nurse station.

Staff/students who appear to have symptoms upon arrival at school or who become sick during the day should immediately be separated from others, and sent home.

If student/staff becomes sick but tests negative for COVID-19:

They should stay home until they are feeling better and they have not had a fever for 24 hours without using any medication to reduce fever.

Contact tracing, isolation and quarantine procedures will follow the most recent guidance of the CDC, DHS and NSHD.

Handwashing

Students and staff will be regularly reminded about the importance of proper handwashing. Teachers may allow for more breaks to give students the opportunity to wash their hands, either at a classroom sink or in a restroom.

Face Coverings

Face coverings will be required for all students, staff and visitors. Students will be required to wear face coverings on buses and school vans. Fully vaccinated staff, students and visitors will have the option to wear face coverings in the building when safe levels of operation have been reached. Safe levels of operation will be determined by administration in consultation with local and state health departments.

We are committed to fostering a respectful environment in which there are no stigmas associated with wearing personal protective equipment. What families need to know about face coverings.

Transitions Between Classes

To help avoid situations in which large groups of students are gathered in one place, we will adjust hallway supervision to ensure students move between classrooms and other spaces in our schools.

Entering School

Family members should not leave their vehicles to enter the building when picking up or dropping off students. Students will be released from the building to vehicles for pick up.

Exiting School

Below are the designated exit doors:

- Bus Riders Athletic Exit
- Student Drivers Main Exit
- Parent Pickup Auditorium Exits
- Students with limited mobility Door #9 and #31

Cleaning and Disinfecting

Our custodial staff will continue with regular wiping down and disinfecting of public spaces and high-touch surfaces across our buildings and throughout the school day. We will also provide access to cleaning materials for our teachers and staff so that they can clean and disinfect spaces as needed.

Each evening, our custodial team will conduct a thorough cleaning of our spaces, again disinfecting high-touch surfaces like sinks, drinking fountains, door handles, tables, and desks.

Field Trips

No field trips will be permitted until further notice.

Air Filtration

Air filtration systems with UV lights have been purchased and installed in large group areas, classrooms, offices and high traffic office areas. Classroom ventilation systems have been cleaned, maintained and upgraded on a routine basis.

Physical Distancing

Physical distancing will return to normal spacing in most settings. Three feet of physical distancing will be implemented where possible.

Isolation and Quarantine

The CDC and Wisconsin Department of Health and Human Services have updated their quarantine guidance as more research is coming out about the effectiveness of vaccines. The most recent update includes different protocols for those who are vaccinated (at least 2 weeks have passed from the final dose of a vaccine) and those who are not.

The CDC and Wisconsin Department of Health and Human Services have different criteria for isolation and quarantine depending on an individual's vaccination status. In general, the CDC and Wisconsin Department of Health and Human Services have defined "close contact" in schools as:

- Individuals who are within three feet of a confirmed positive case, during the infectious period of the positive person, for a cumulative total time of 15 minutes or more over the course of a 24 hours period
 - "Infectious period" is defined as the 48 hour period of time prior to the individual presenting symptoms or the date of their positive test.

Please see below for information on quarantining, depending on your vaccination status.

For those who ARE vaccinated to protect against COVID-19 (at least 2 weeks after their last dose of a vaccine series):

In alignment with the North Shore Health Department, CDC and Wisconsin Department of Health and Human Services, vaccinated persons with an exposure to someone with suspected or confirmed COVID-19 **are not required to quarantine** if the meet the following criteria:

- Are fully vaccinated (i.e. exposure to someone with COVID-19 happened at least 2 weeks after receiving the last dose of their vaccine series), **AND**
- Have not had any symptoms of COVID-19 since the current exposure.

Unvaccinated individuals who do not meet the above criteria should continue to follow the guidance listed below.

For those who are **NOT** vaccinated:

When an individual tests positive for COVID-19 or comes into "close contact" with someone that tests positive for COVID-19 they will need to transition into isolation/quarantine. Close contact is defined as being within three feet of someone that tested positive for COVID-19 for at least 15 cumulative minutes over a 24-hour period. Close contact will be determined based on the findings of the District and local health department's contact tracing efforts. The following chart delineates how long an individual in such situations will need to be isolated/quarantined before being able to return in-person again. Please stay in contact with your healthcare provider, school healthcare personnel, and the local health department. They will guide you through the quarantine and isolation process and will determine the best date for returning to in-person instruction for your student.

Isolation and Ouarantine Process

- 1. The High School Office will coordinate the contact tracing process, with the assistance of the School Nurse, Student Supervisors, and District Office, when needed.
 - a. The High School Office or designee will contact (phone) the positive person and/or family to determine who from the school environment the positive individual came into contact with in the 48 hours prior to their positive test or onset of symptoms.
 - b. The High School Office or designee will work with classroom teachers and staff members where the positive case has occurred to determine any additional close contacts in need of being quarantined.
 - i. This involves reviewing classroom seating charts, classroom activities, etc.
 - c. The High School Office or designee will review extra curricular, recreation department, and any other Nicolet High School activity that the student participates in. If an activity(ies) are identified, the High School Office or designee will contact the Athletic Department (coach), advisor, or person in charge of the activity to determine if any close contact occurred with the positive case during the activity.
 - d. People identified as close contacts will be contacted by the School Nurse or designee and be made aware that they are considered a close contact with a positive case and will need to quarantine, based on their last date of contact with the positive person. The School Nurse or designee will specifically identify the date of return for the person identified as a close contact. Additionally, the School Nurse or designee will identify any additional members of the close contact's household who also attend Nicolet High School and may be affected.
 - e. The School Nurse or designee will provide written notification in follow up to the phone call of any close contact quarantine. The written notification will include the date the person is able to return to the school campus.
 - f. The High School Office or Designee will email all staff to make them aware that a positive case has been in the building during the person's contagious period and that close contacts have been identified and contacted.
 - i. *This step will only occur if the person was on campus during their contagious period (within 48 hours of a positive test or onset of symptoms)
 - g. The High School Office or designee will send a Skyward email to families of the school making them aware that a positive case of COVID-19 has been identified on campus, and that contact tracing for close contacts has occurred.
 - i. *This step will only occur if the person was on campus during their contagious period (within 48 hours of a positive test or onset of symptoms)

School Calendar

Regular school events and activities will take place for 2021-2022.

Transportation Safety

- Hand sanitizing stations on all buses.
- Assigned Seats: There will be assigned seats on all buses.
 - Assigned seats both ways to allow for contact tracing.
- Students will load back to front to avoid passing by students in the morning.

- Signage will be placed on all buses related to safety for COVID.
- After each route (high school, middle school, elementary school) high touch areas such as seat backs and railings will be cleaned.
- Electrostatic foggers will be used at least once per day to sanitize the bus as soon as possible (currently on back order).
- Masks: Drivers and Riders required to wear a mask.
 - o Masks on the bus for students attempting to ride without one.

Route Planning

A 45 minute route time limit has been set at guidance to minimize student contact on buses.

Visitors

Campus visits will be limited to visitors with a scheduled appointment only. Visitors will not have permission to enter campus without pre approval. All visitors will be screened by the front desk staff using the <u>Nicolet District</u> <u>COVID-19 Screening Tool</u>. Visitors will be escorted to and from their scheduled appointment.

COVID-19 Testing

COVID screening tests will be available on a daily basis to all students and staff on a voluntary basis at the beginning of each school day. Students or staff who elect to participate in COVID screening may enter the building through the athletic entrance to go directly to Room B111. Test results will be made available to the individual as soon as possible on the same day. Students and/or staff who test positive will follow the isolation/quarantine procedures set forth above.

Continuity of Services

Student Services

The Nicolet Student Services Department consists of four full-time counselors, a social worker, and school psychologist working collaboratively towards helping students achieve personal, academic, college, and career readiness while maintaining a healthy, balanced lifestyle. Student Academic Needs

The Nicolet High School District has implemented a summer school program to assist all 9-12 students with academic recovery. The District plans to continue full-time, in-person instruction beginning the fall of 2021, with limited exception. Students who must remain remote due to significant health concerns will be accessing curriculum through the Edgenuity digital curriculum program coordinated by a licensed Nicolet teacher. A student support coordinator has been added to the student support team to oversee students needing additional services. The coordinator is a licensed professional school counselor which is another layer for students struggling with social, emotional well

being. In addition to the coordinator, Nicolet's student support team consists of a licensed literacy specialist, math specialist, alternative education specialist, and two academic paraprofessionals to support further academic recovery efforts in core curriculum areas. These specialists will be available during the instructional day and/or during before and after-school tutoring programs throughout the year. Guided study hall, before and after school tutoring will be available to students. Arrangements can be made through the student's counselor. Nicolet teachers have implemented diagnostic assessments for each unit to inform teaching and learning and to identify possible gaps in learning.

Staff Social, Emotional, and Mental Health Needs

The District has provided staff with opportunities for social and emotional support through on-site 3rd party support sessions, and wellness sessions built into staff workshop days. The staff's social, emotional, and mental health needs may also be addressed through the Employee Assistance Program provided through the District insurance program.

Other Staff Needs

The District will follow national, state, and local governing agencies' laws and directives concerning staff employment and benefits. The District has extended COVID-19 leave days for staff absences related to COVID-19 illness or to care for family members with COVID-19.

Student Social, Emotional, and Mental Health Needs

The Nicolet High School District will be administering the Developmental Assets Profile (DAP) Survey to all students in grades 9-11 to measure the social-emotional well being of students. Students in grades 5-8 from Nicolet's partner schools will also participate in the survey. Using the survey results, student services staff from Nicolet and the partner schools will collaborate to develop a K-12 Social-Emotional Action Plan. Counseling and student services staff will continue working daily to meet the social-emotional needs of students.

Other Student Needs (which may include student health and food services)

Food Service

Three lunch periods will be offered to increase physical distancing during the lunch period. Food service will resume following recommended safety guidelines. In the event of a school shut down the Nicolet Food Service staff will provide school lunch through a pick up process for our students.

Periodic Review

Nicolet Union High School will periodically review and, as needed, revise the plan for the safe return to in-person instruction and continuity of services. The plan will be reviewed at least once every six months and the district will seek and take into account public input during the review process. The plan review will consider COVID-19 school and community data. Revisions will address updated local, state and national public health guidance on safe reopening of schools if any are issued.
